Meeting Minutes January 20, 2020

CALL TO ORDER

The monthly meeting was called to order on January 20, 2020 at 6:00 pm. by Chairman C.L. Tuff Rine Jr.

PLEDGE OF ALLEGIANCE

The Pledge of Allegiance immediately followed.

ROLL CALL

Supervisors Kenny McGhee Jr., Clarence "Tuff" Rine Jr., and Steve Tasselli were present. Secretary/Treasurer Marissa Morgan was present. Solicitor Frank Miceli was present.

AGENDA

Motion was made to approve the January 20, 2020 Agenda by Steve Tasselli and seconded by Kenny McGhee Jr... Motion was carried unanimously.

Zoning Hearing – Change of Zoning – Williamsport Hospitality PartnersZoning Hearing called to order at 6:02 pm.

There is a proposed ordinance to change the zoning of the following properties currently owned by Louse S. Winner Jr. from Agriculture to Open Space Recreation: Parcel IDs 3-24223, 3-24225, 3-945. Court Reporter James Williamson was present recording all discussions and comments. All supporting documentations were made available including proof of publication of notices, affidavits notice to adjoining property owners, certification of properties posted, county planning recommendation letter, bald eagle township planning recommendation, cover letter to county law

Kim Stiles, adjacent property owner, asked if an impact study was done for the impact on nearby properties. Frank Miceli responded that a study would be required to future development but this is for approval of a zoning change.

Kim Williams, adjacent property owner, had concerns of traffic changes on Country Club Lane. There is already existing concerns and adding additional traffic would only worsen existing problems.

Peg Johnson, owner of business on Hogan Blvd, questioned the impact of existing business in regards to water and flood issues.

Chris Stein, GOH Engineer assigned to the proposed project, expressed that in the land development plan all storm water will be eliminated from any off site discharge. Developer is more than willing to address traffic concerns with the Township.

No motions were made to proceed at this time.

The Hearing was adjourned at 6:14 pm.

HEARING OF VISITORS

Jutta Braune, 94 N. Parsons Drive

Ms. Braune would like a "dead end" sign erected in front of her property. She expressed there is no appropriate sized turn around and her driveway is being utilized as the turn around. She also had a concern of snow removal. She stated the plowing stopped in the middle of her driveway and believes it should continue to the end of the cul-de-sac that is currently there.

The Board explained that their understanding is that this cul-de-sac was to be temporary until Phase #3 was developed. To their understanding, Phase #3 is no longer being developed as planned. The Board will look into what options are available to make an appropriate turn around space.

Dan Duck - Mill Hall Fire Company

Dan Duck reported on behalf of Mill Hall Volunteer Fire Co. that there were 157 called in 2019, 88 being in Bald Eagle Township. C.L. Tuff Rine Jr. asked Mr. Duck if anyone from the Fire Company spoke to the Express about funding they receive. Mr. Duck stated he is not aware of anyone talking to the Express.

Roland Weaver – Clinton County Sewer Authority

Mr. Weaver informed the Board of Supervisors the CCSA is currently in the process of electrical upgrades at the County Sewer Tank. He would like to continue having a working relationship with Bald Eagle Township.
